LEAP Course Outline

- Early warning signs of layoffs and plant closings;
- Job Retention and Job Transition Strategies and Services;
- Effective use of the New Jersey Labor & Workforce Development (LWD) Rapid Response Team;
- Worker Advocacy within the New Jersey LWD system of services: basic skills, resume assistance, job search, education and training programs;
- Resume preparation through dislocated worker skills assessment;
- Site visits to New Jersey's One-Stop Career Centers;
- Dislocated worker policies, laws and benefits: Warn Act, Trade Adjustment Assistance, and New Jersey Family Care;
- Social and emotional support for laid-off workers through the New Jersey State AFL-CIO Community Services Network;
- Lifelong learning for all workers - Tuition Waivers, Adult Education, ESL, GED, College Credits for Apprenticeship, and the National Labor College.
